

Working under the blessed guidance of Bishop Noonan, The Catholic Foundation of Central Florida presents our 2016 Annual Report, outlining a year when we laid a strong foundation to serve our faith community for years to come. As I close out my final year as chairman, it is uplifting to see that The Foundation is healthier than ever and serving everyone especially young Catholics - in new ways.

At the University of Central Florida, for example, the Catholic Campus Ministry (CCM) offers spiritual oasis to thousands of students through Mass, fellowship meals and chapels for prayer. The ministry created an eight-person advisory board in 2016 and held "Sapphire Knight," a fundraising event that united donors, students and other supporters who share our Catholic faith.

Meanwhile, The Catholic Foundation in fiscal 2016 launched a pilot program at four parishes, "With All Your Heart," in partnership with Greater Mission, a Baltimore-based consulting firm. The program is designed to strengthen parish life and form Disciples of Christ by increasing involvement, generosity and membership. This led to the creation of a youth group at Santo Toribio Romo Mission in Mascotte where as many as 25 teenagers gather biweekly for prayer and fellowship.

The Foundation also excelled in other areas of fundraising. In fiscal 2016, Our Catholic Appeal - an annual opportunity for parishioners to support the life-changing work of the Diocese of Orlando - collectively raised more than \$15 million from about 44,000 donors, surpassing its fundraising goal. Our Catholic Appeal is the sole source of funding for 27 ministries that benefit every parish, mission and school in the diocese. At Melbourne Central Catholic, a new era for Catholic youth began with a campaign - facilitated by The Foundation - to modernize the high school campus that champions Jesuit values. In 2016, the school raised \$3.2 million in the campaign's first phase, surpassing its \$2.4 million goal.

With an eye toward long-term fundraising, The Foundation added new services in 2016. As part of the Planned Giving program, we launched regional "Catholic Legacy" seminars that attracted a total of nearly 900 guests to 22 seminars in 2016. And The Foundation expanded its investment suite for parishes with a new option: a Quasi-Endowed Portfolio for clients with an investment time horizon of five years or more.

I am grateful to have served as chairman the past three years, and worked alongside Meghan. On behalf of The Foundation Board, we look forward to continue serving you and delivering an even brighter future for the Catholic community in the Diocese of Orlando.



2 Future planned gifts are those in which a donor has notified us of a gift intent, which the Church will receive when they pass away. This is a conservative valuation as it includes undisclosed gift amounts.

The average matured gift is \$114,862. At this rate, these future gifts could be an estimated \$3.6 million when they mature.



How We Serve Offertory Enhancement Initiative

Sustained offertory increases play a critical role in the ability of a parish to serve the community and minister to God's people. Parishes rely on regular offertory giving to meet day-to-day expenses. The Catholic Foundation facilitates the Offertory Enhancement Initiative (OEI). This one-year program is a gentle path to offertory enhancement with a spiritually sound approach. It uses best practices to increase parish enthusiasm and giving. Sixty-six parishes and missions have participated in OEI since the program began in the Fall of 2012. In that period, first-time parishes have seen an average offertory increase of 13%, with some parishes experiencing

gains surpassing 20%. It is a best practice to repeat the initiative every three years. Seven parishes that have re-enrolled in the OEI program have received an average additional 11% increase in their offertory.

WITH ALL Your Heart

Four parishes in the Diocese of Orlando participated in a twoyear pilot program called "With All Your Heart/Con Todo Nuestro Corazon." This parish-based bilingual program invites parishioners to grow spiritually, build community and give faithfully to form as Disciples of Christ.

This model, done in partnership with Greater Mission, a Baltimore-based consulting firm, offers a yearlong cycle of opportunities for church members to become more active in developing their faith life and parish community. Parishes will have the option to use the "With All Your Heart" model beyond the initial two-year period.

Here's a look at how donations from our *Alive in Christ* campaign have served Central Florida since the launch of the campaign:

- More than \$86 million was returned to parishes to complete projects including building, renovating and expanding churches.
- \$249,000 from the Catholic Charities of Central Florida, Inc.
 Endowment Fund was distributed to Catholic Charities to support services such as the food pantry, free healthcare for the uninsured, housing help and emergency financial assistance for people in need.
- \$150,000 from the Tuition Assistance Endowment Fund was used to assist 68 students with Catholic School tuition.

Bringing their dream to life

ALIVE IN CHRIST

The renovated campus at St. Joseph Catholic Church in Winter Haven has united the parish's ethnically diverse members in powerfully visible ways.

In the courtyard, for example, parishioners born in places including Vietnam, the Philippines, Haiti, Latin America and the U.S. have united to pray the Rosary together, alternating between as many as 16 languages in community worship. In the remodeled cafeteria, international meals have united parishioners in conversation and fellowship.

The communal gatherings are occurring in parts of St. Joseph's campus updated because of the generosity of donors who have given to the *Alive In Christ* (AIC) campaign. Donors have helped the AIC campaign raise nearly \$150 million throughout the Diocese of Orlando. This generosity has funded parish expansions, renovations and new-church construction in the past decade.

> At St. Joseph, donor gifts to the AIC campaign paid for the courtyard, renovated Parish Center and parking lot, walkway awnings, wheelchair-accessible restrooms, gift shop, and a new kitchen and cafeteria. The renovations, which were completed in January 2015, have helped St. Joseph become a spiritual nexus for Catholics in this small but diverse city of roughly 37,000 residents.

> > At St. Joseph, "all ethnicities come together and bear witness to Christ together," says Father Joseph Nguyen, a Vietnamese émigré who lived in Toronto, Canada, for nearly three decades before relocating to Winter Haven in 2015. "We worship the same God."

Remembering through love and generosity

Planned Giving

For Mrs. Eva Finley, generosity is a family tradition. In the late 1800s, her great grandmother generously served meat, beans and tortillas to Native American neighbors in New Mexico to ease their hunger.

Growing up in Los Angeles, Mrs. Finley, 78, and her Catholic school classmates often fed the homeless through school-sponsored events. Today, Mrs. Finley, a lifelong Catholic who attends Nativity Church in Longwood, continues her spiritual generosity: she feeds the hungry at a local food bank, financially supports her parish and - with the help of The Catholic Foundation of Central Florida - has donated money to establish several charitable gift annuities that will support Nativity Church, and the San Jose Mission in Pierson, which assists migrant workers.

In return for her donation, the annuities offer Mrs. Finley fixed-quarterly payments for the rest of her life. To establish an annuity gift, donors must give at least \$20,000, and be at least 60 years old. "Church has always been at the center of my life," says Mrs. Finley, who with her three siblings attended Catholic school from kindergarten through 12th grade. "Giving is natural to me." Growing as a community

OFFERTORY ENHANCEMENT

Parishioners at St. Margaret Mary Catholic Church in Winter Park are known for generosity to their church. Their generosity extends to providing ongoing financial assistance to overseas parishes and schools in Haiti and Uganda.

So, when Father Richard Walsh and the Parish Council felt that the parish campus needed some infrastructure improvements in 2016, he knew a successful way to solicit the necessary funds: Father Walsh partnered with The Catholic Foundation of Central Florida, which created a customized plan to enhance parishioner donations. Through the Offertory Enhancement Initiative (OEI), The Foundation partners with parishes seeking to raise capital for projects including expansions, renovations and maintenance improvements.

> The result: offertory donations jumped more than 20 percent at St. Margaret Mary, the largest increase among parishes in the Diocese of Orlando for fiscal 2016. St. Margaret Mary used the additional donor gifts to cover the costs of re-roofing the church, repairing and maintaining the church exterior, and re-landscaping.

Since OEI began in 2012, 66 parishes and missions have enrolled in the program and collected a total of \$7.5 million in additional donations. "I would highly recommend the good work offered through The Foundation," Father Walsh says. "They do their homework and are available at all times."

College life inspired by faith

Juan Arreguin was studying business at a university in his native Mexico when academic crisis hit: His true wish was to pursue music, so he ditched the business-career path and traveled to Florida to study music at Full Sail University in Orlando.

The lifelong Catholic was thrilled to pursue his musical dream and quickly found a local church to meet his spiritual needs. At church, the 20-year-old was told that he could connect with hundreds of other university-age students by joining the Catholic Campus Ministry (CCM) at the University of Central Florida (UCF).

Today, Juan is among the more than 2,500 students who annually attend Mass and Meal at CCM, which is open to all college students, including those at UCF, Full Sail, Valencia College and Seminole State College. CCM offers Holy Mass, bible study, music ministry and religious retreats, among other services. CCM reaches students - most of whom are in their 20s - at a vulnerable age when many are wrestling with academics, career aspirations, daily life or faith. A 2016 study by PRRI, a nonpartisan Washington D.C.-based research group, revealed that nearly two in five Americans aged 18 to 29 do not have any religious affiliation- the highest of any demographic.

Through CCM, Juan's Catholic faith has deepened and he is now a Eucharistic Minister. CCM is "my home away from home," he says. CCM is "my home away from home." - JUAN ARREGUIN

Priest Retirement Program

For 40 years, Father Edward McCarthy dedicated his mornings to serving parishioners in the Diocese of Orlando by offering mass, overseeing seminarian training, priest personnel as well as running the Basilica of the National Shrine of Mary, Queen of the Universe. These days, Father McCarthy, 73, spends mornings caring for elder priests as Vicar for senior clergy, doing part-time pastoral work, and growing tomatoes and peppers at his home garden.

Father McCarthy attributes his retirement serenity to the grace of God, the help of financial planners, saving and a Diocesan retirement program funded by parishioners that assists 53 elder priests. The retirement program supports the spiritual, pastoral and human needs of senior diocesan priests, providing them with resources to manage their financial, housing and medical needs. It allows priests to live with dignity in retirement-recognizing their decades of service.

"I've given my life to take care of parishioners. Now they're taking care of me," Father McCarthy says. "We're family. I'm grateful for the tremendous generosity of the people."

A new generation of faith leaders SEMINARIAN EDUCATION

The roots to Derek Saldanha's faith trace to Pune, India, where he was raised Catholic in a bustling city. The threads of Catholicism and capitalism propelled Derek to a Bachelor's Degree in Business, and then he moved halfway around the world to get a Master's Degree in Educational Administration at a Franciscan College in Steubenville, OH.

While studying in Ohio, interacting with the local community had him "discerning the priesthood," says Derek, 31. "I met a lot of people who were stressed, doing drugs, but the Lord changed their lives."

Derek spent summers visiting relatives in Melbourne where he attended Holy Name of Jesus and worked part-time at a gas station. One day, he caught a van ride organized by the Diocese of Orlando roughly 200 miles south on I-95 to St. John Vianney College Seminary in Miami where life became clear. "I had a feeling of great peace" at the Seminary, he says. "This is where I belong. God is calling me."

After seven interviews, Derek was accepted to the seminary in the summer of 2012. Some seminarians come straight from high school, others have a Master's Degree before entering the seminary, and a portion were professionals. It costs \$45,000 annually to educate each seminarian, including their tuition, books, medical insurance, food and housing. Since its founding in 1968, the Diocese of Orlando's seminarian program has ordained 128 priests, and now educates from 25 to 35 seminarians in a typical year.
