

Giving USA 2020, a report researched and written by Lilly Family School of Philanthropy, shares for the third year in a row that contributions to the religion sector comprised 29 percent of all donations received by charities in 2019. Giving to religious organizations increased 2.3 percent from 2018.

Though religion is still by far the largest charitable sector, its share as a percentage of total giving has diminished over time. For example, in 2009, religious donations represented 36 percent of total giving. This decline is not due to year-over-year declines but rather reflects that religious giving is growing at a slower pace than some other charitable sectors.

Another report from the Lake Institute on Faith Giving at Lilly Family School of Philanthropy, reports that the slow growth in religious giving can be attributed to several factors. This study found the majority of Catholic parishes faced losses in both revenue and size of members from 2014 to 2017. The report also shares how religions, including Catholic, not only give to themselves to sustain their faith but also give beyond the religious sector to support human and social service projects.

The same year, the Women's Philanthropy Institute's study found that there is an added bonus to giving. For example, giving is positively related to life satisfaction and the more people give, the more satisfaction they feel. An earlier study by Harvard and the University of British Columbia found that spending money on others leads to lasting improvements in overall happiness. There are several other studies that confirm these findings and add that volunteering, and helping neighbors and friends, lowers mortality rates.

At The Catholic Foundation of Central Florida, we are blessed to have the opportunity to support donors throughout the diocese giving generously to the ministries on their hearts through services such as complex stock transactions, updating credit card information, establishing endowments and providing updates on ministries and programs. We walk with donors on their philanthropic journeys regardless of their giving amount as we understand that the amount is not as important as the act of giving itself. Not everyone can make the same size gift but everyone can make the same size sacrifices and receive the same benefits.

Benefits of Giving

Physical – As the studies referenced have concluded, there are physical benefits to being a giver of time, talent and treasure.

Relationships – We are called to return our gifts to God and when we give, we respond to His call and strengthen our relationship with Him. When we volunteer, we deepen relationships with those we serve and those we serve with.

Personal Values – Having the power to improve the lives of others, give back to others, and to build the Kingdom of God is a privilege and for many this privilege comes with a sense of responsibility. Taking action with this sense of responsibility reinforces our own personal values and confirms our own ethical beliefs.

Positive Influence – Sharing the experience of giving with your children shows them how each person can make an impact in our world. While giving of our treasure involves transactions of assets, we transition our values to the next generation when we engage youth with giving. Your own charitable donations and actions can also inspire others to do the same.

Impact – Amid the coronavirus pandemic, the difference we make through charity is more impactful than ever. The community need for housing assistance and access to food and health care has never been greater. Many of our parishes and diocesan entities are experiencing loss of revenue due to social distancing. Several individuals and families have been impacted by the pandemic and are unable to give at this time. Anyone able to give any amount can make a big impact today and help bring our world to its fullness of charity.

As parishes work to meet operational expenses without regular, pre-pandemic weekly offertory revenue, now is the time to implement an online giving campaign. Doing so will have the ongoing positive impact of converting a greater percentage of parishioners to online giving. In addition to enabling the parish to count on regular revenue for the duration of the COVID-19 pandemic, this strategy will also provide steady income when donations at Mass decrease for a variety of reasons, such as weather emergencies, seasonal variations in attendance, and parishioner vacations.




