We are thankful for our board, staff, diocesan partners, clergy and religious and our Central Florida community. May God bless you all!





YEAR-END GIFTS GUIDE



It is the most generous time of the year and there is no better way to celebrate Jesus' birth than by sharing the gifts we have received with others. There are many ways you can easily support your parish, school, Our Catholic Appeal or an endowment or reserve fund for your year-end giving and enjoy some tax advantages too. However, there are important dates to consider for your gifts to be eligible for inclusion on your 2020 tax return. Please remember that many offices are closed during the Christmas season and incorporate that detail into your year-end gift planning and activities. To help with your planning we have prepared a year-end gift guide. We hope this is helpful - please contact us if you have any questions.

GIFT TYPES

1. Cash Gifts

Online gifts: Online credit card gifts can be made up to midnight on December 31, 2020. <u>Click here</u> for The Catholic Foundation's gallery page of our Diocesan entities and ministries to find the area of interest on your heart.

Mailed gifts: Gifts can be made by check and mailed and should be postmarked by December 31, 2020. Please make checks payable to your parish, school or ministry organization.

2. Appreciated Stock

Stock gifts: Stock transfers should be received in our account by December 31, 2020. The Catholic Foundation's detailed information for you and your broker and contact information for extra assistance can be found <u>here</u>.

3. IRA Rollovers and Distributions

Gifts from your IRA must be received by the charity by December 31, 2020. <u>Click here</u> for instructions to share with your IRA custodian, as well as our contact information so that you can advise us that your gift is on the way.

Legacy Planning Webinar Series



Now more than ever, we are looking for peace of mind. It is estimated that **more than half of Americans don't have an estate plan**, yet 71% say that having a well-thought-out estate plan would help them feel better. In an effort to help Catholics throughout the Diocese of Orlando formalize their plan, The Catholic Foundation of Central Florida presented its first virtual **Legacy Planning Seminar** in a 3-part webinar series. Our inaugural webinars had **167 registrants** for the 3-part series that featured experts from The Catholic Foundation's Planned Giving Advisory Council including Wills and Estate Attorney, **Amber Jade Johnson**, from Amber Jade Johnson PA; 401K Specialist/Wealth Advisor, **Ty McCormack**, from Aksala Wealth Advisors; and Founding Partner of F4 Wealth Advisors, **Darrell Devaney**. These presenters provided the attendees with valuable information on Wills and Estate Planning, Financial Planning, and Taxes and Estate Strategies. Each webinar included a Legacy Planning Tip to assist attendees with: Transitioning Values to Your Children and Grandchildren, How to Protect and Strengthen Your Family, How to Create a Family Mission Statement.

Webinar attendees received digital copies of a 28-Page Wills & Estate Planning Guide, Catholic Advance Medical Directive and Guide to Understanding It, Legacy Journal, Guide to Creating a Family Mission Statement, and Guide to Creating a Legacy Video. They could also sign up for a free 1-hour consultation with an Estate Attorney, Financial Consultant, or Philanthropic Advisor.

A Thrill of Hope
