As Catholics some of us have been raised with the full traditions of the Lenten season: prayer, fasting, almsgiving, reflection, confession, etc. while others grew up practicing only fasting two days (Ash Wednesday and Good Friday) and no meat on Fridays. Regardless of how we were raised, we are all practicing what we were taught to prepare and celebrate our Lord's Resurrection at Easter. The Resurrection guides us in understanding the value of our life and our purpose in life. When our life is based in His word, His sacrifice and in our prayers.

In our prayers may we experience a constant awareness of God's goodness. Through this awareness our gratitude grows within us, preparing us to offer ourselves freely for the building of His Kingdom on earth.

The Resurrection proclaims that Jesus is with us in our lives today. The same Jesus that walked, talked and ate with the Apostles is present with us. His Resurrection conquers death in our world, as foretold by the prophets, His is the victory and we are assured of eternal life. Jesus was resurrected, body and soul, affirming the value of our humanity. This value expresses God's love for us and the profound unity we have with the all-loving God through Jesus's Resurrection.


